**BOYCOTT Papa John's Pizza! Fight for Respectful and Inclusive Workplace
with Equal Employment Opportunity for All!**

PLEASE READ THIS

My fellow citizens:

With great sadness I must ask you to **BOYCOTT** the Papa John's Pizza locations in South Lyon and Northville.

For the past three years, like many others, I worked and floated between both stores. I tried very hard to help support this employer and went above and beyond of what anyone asked of me. Regular customers will recognize me as *"the guy on crutches working by himself."*

My employment ended in early May because I was a whistleblower. I contacted the Oakland County Health Department when my employer refused to restore water service to a handwash sink in the food preparation area. According to the health department records, water service was shut off to the sink as far back as **October 2019**. In other words, when **COVID-19** was at its worst during 2020 and 2021,

employees were **unable** to wash their hands in the food preparation area of the store. This was **irresponsible** of the franchisee.

In April of 2022, I bit the bullet for **you**, the general public, and put my job in jeopardy to make sure that sink got fixed. Between both stores, as of January 2022, **I was the only individual who possessed a valid and current Certified Food Service Manager Certificate**. Not even the franchisee or the General Manager were certified. As I was the certificate holder, and because I was practically the Assistant Manager, the responsibility of food safety fell to me.

Customers have witnessed me on crutches in the stores, on more than a few occasions. I know so because myself, and the franchisee have both seen your compliments come through the internet. Those comments, along with every complaint regarding the undercooked food, is received, I assure you.

Less than two weeks went by after the Oakland County Health Department finished their follow-up inspection to ensure the sink was repaired. Then, my employment came to a screeching halt. The **excuse** was my **disability** because the franchisee thought I was too “fragile” and “unable” to perform the job. As I said before, I was there for three years, had more responsibility than most people, and was essentially the Assistant Manager.

My termination was a **wrongful discharge**. Not only do I have a **retaliation** case against the franchisee, but the excuse I was given presents itself a **discrimination** case as well. In addition to everything I just said, everything on my list above can be verified and talked about in much detail.

My fellow citizens, if you submit a FOIA Request to the **Wayne & Oakland** County Health Departments for the **Restaurant Inspection Reports** of the last 3 years, you will receive about 50 pages of material filled with health code violations.

Please BOYCOTT both Papa John’s Pizza locations above.
